1. License Grant

LICENSOR grants to LICENSEE a non-exclusive, non-transferable, license to use the SOFTWARE under the terms of this Agreement.

Fluid Interactive, Inc. retains ownership of all copies of the SOFTWARE and except for the limited rights granted herein, Fluid Interactive, Inc. shall own all rights, title and interest in and to any and all copies thereof, including all Intellectual Property Rights therein. No license or right is granted, by implication, estoppel or otherwise, to you or to any third party under any of Fluid Interactive, Inc.'s Intellectual Property Rights in the SOFTWARE, except for the licenses and rights expressly granted in this Agreement. The SOFTWARE is protected by Italian copyright laws and international treaties, and the unauthorized reproduction or distribution thereof is subject to civil and criminal penalties

This Agreement constitutes the entire agreement between LICENSOR and LICENSEE and governs LICENSEE's use of the Software, superseding any prior agreement between LICENSOR and LICENSEE relating to the subject matter hereof.

This license is restricted to your personal use. This license permits you to:

- A. use a copy of the SOFTWARE on a single computer;
- B. make one copy of the SOFTWARE for backup or archival purposes only;
- C. use the SOFTWARE over a network, provided that you own a license of the SOFTWARE for every computer using the SOFTWARE over the network;

You shall not:

- A. use, copy, merge or transfer copies of the SOFTWARE, except as specifically authorized in this EULA;
- B. rent, lease, sublicense, distribute, transfer, copy, modify or timeshare the SOFTWARE or any of your rights under this EULA, except as expressly authorized in this EULA;
- C. provide unauthorized third parties with access to or use of the SOFTWARE;
- D. reverse engineer, disassemble, decompile or otherwise attempt to access the source code of the SOFTWARE, except and only to the extent that such activity is expressly permitted by applicable law;

2. Termination

LICENSOR may immediately terminate this Agreement and the license granted hereunder if

LICENSEE fails to comply with the terms and conditions of this Agreement. Upon such termination, LICENSEE must immediately cease using the Software, destroy or delete all copies of the SOFTWARE and upon the request of LICENSOR, certify the destruction or deletion of the SOFTWARE. LICENSEE may terminate this Agreement and the license granted hereunder at any time by destroying or deleting all copies of the SOFTWARE. ALL DISCLAIMERS, LIMITATIONS OF LIABILITY AND ANY OTHER PROVISIONS INTENDED TO SURVIVE TERMINATION WILL SURVIVE ANY TERMINATION AND CONTINUE IN FULL FORCE AND EFFECT.

3. Data collection

Fluid Interactive, Inc. may collect anonymous data from you when you use the SOFTWARE. This information is gathered periodically to facilitate the provision of software updates, product support and other services related to the SOFTWARE.

4. Purchase of a License and Support

If you purchase a license of the SOFTWARE, you'll receive, included in your purchase, one year of support service. During the validity of the support service you'll receive all the updates to your purchased SOFTWARE for free. This guarantees that the SOFTWARE will work on the version of SketchUp available at the time of your purchase and all versions of SketchUp released within one year of your purchase.

5. Support Renewal

Each time before the expiration of the support, you'll be offered the possibility to extend the validity for one extra year at a 75% discount on the full price of the SOFTWARE. If you decided to renew after the expiration of the support, you'll be able to extend the support at a 25% discount on the full price of the SOFTWARE. Every time the support is renewed, it's validity will be extended for one year, starting from the date the support extension is purchased.
